

## **Uploading CAR Evidence:**

The Portal also streamlines the process to submit evidence for any CARs you receive during an audit. You must submit **all** evidence for **all CARs issued** during a single audit by the due date. Any additional evidence you submit after that initial upload will be counted as the CAR reviewer's **second request** for documents per **GR6.2.1** of the *Governing Requirements for Certification Programs*.
