Introduction

This official scoring spreadsheet is to be used at all regional competitions and the National Finals. It is a Microsoft Excel Visual Basic macro driven tool, and the **use of Excel 365 is highly recommended**. Click the buttons below to download the spreadsheet and the accompanying user's guide.

The host school should submit the completed scoresheet to sbcscorekeeper@aisc.org immediately following the competition. The Rules Committee will use this spreadsheet to resolve appeals and to issue invitations to the National Finals. Note that no school at a regional competition will be invited to the National Finals unless this spreadsheet has been submitted.

Overview

The Student Steel Bridge Scoring Spreadsheet (henceforth referred to as “Scoring Spreadsheet”) is a Microsoft Excel Visual Basic macro driven tool that is used to streamline the scoring process for both Regional and National competitions. In almost all cases, macros define the behavior of the Scoring Spreadsheet while calculations of values are performed using standard Excel formulas which are dynamically injected once all competing schools have been entered. The Scoring Spreadsheet also makes extensive use of both named variables and tables.

Warning: Users should make no changes to named variables, tables of populated formulas (e.g., renaming, deleting, or adding) or sheet names (i.e., worksheets). You should also never need to manually unhide any hidden worksheets.

Note: You will not be provided any access to the VB code used in this Scoring Spreadsheet.

Reporting Spreadsheet Errors

Please report all potential spreadsheet errors AS SOON AS POSSIBLE to sbcscorekeeper@aisc.org.

If you find an error in the computations that must be fixed, you must contact the developer ASAP. Please report the error right away to sbcscorekeeper@aisc.org so that the spreadsheet can be fixed.

First Run

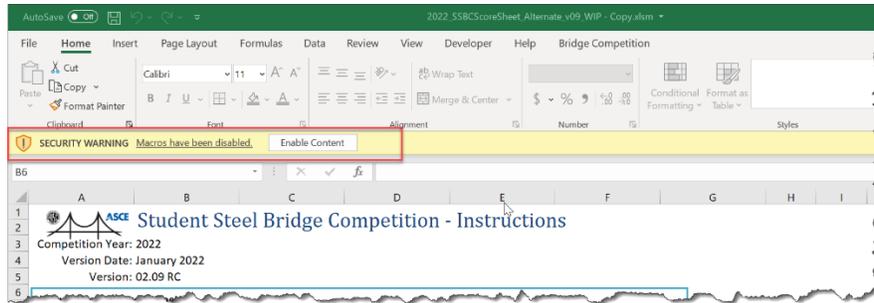
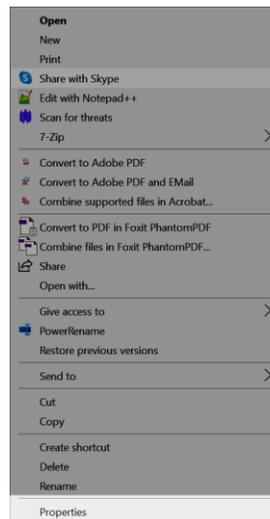


Figure 1: Excel Macro Security Warning.

The Scoring Spreadsheet will not operate unless its macros have been enabled. By default, Excel will disable macro execution and it is the user’s responsibility to enable them when they first open the Scoring Spreadsheet. When you open the Scoring Spreadsheet, a yellow message bar will appear with a shield icon and the Enable Content button (see Figure 1). For the Scoring Spreadsheet to properly operate, you will need to make sure that you have enabled macros by pressing the “Enable Content” button located in the yellow message bar.

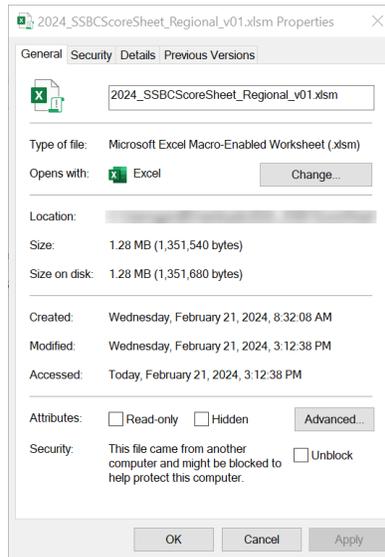
If you do not see the “Enable Content” message after opening the Excel file, you may need to first “Unblock” the file. Close Excel and then open Windows Explorer. Right clicking on the Excel file in Windows Explorer and selecting “Properties” (Figure 2) from the pop-up menu.

After selecting “Properties”, you will see a properties dialog (Figure 3). At the bottom of the first tab, “General”, you will see a check box called “Unblock”. Check this box, press “Apply” and then press “OK”. Open the spreadsheet again and you should see the “Enable Content” option and/or macros should now be enabled.

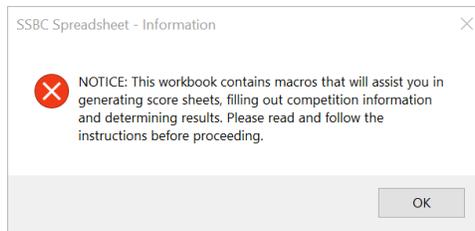


Figure 4: First Run Alert Box.

After enabling the Scoring Spreadsheet macros, you will see an alert box that provides you with some basic direction (See Figure 4). Once you have read these directions, press “OK” to continue. This dialog will only appear if you are opening the spreadsheet for the first time or if you have performed a reset. At this point, the Scoring Spreadsheet will be ready to use, accept competition information and calculate results.

Note: You should verify that you have the names of all schools that plan on competing before you start using the spreadsheet. Once you have entered the competing school names and executed the steps that populate the remaining sheet and tables, you will be unable to add new or remove existing schools without resetting the Scoring Spreadsheet and starting over again.

Spreadsheet Layout

The Scoring Spreadsheet generally operates like any ordinary Excel spreadsheet. It has been organized to facilitate the following steps:

1. Entry of competition information.
2. Entry of competing school names.
3. Printing of aesthetics judging forms.
4. Printing of competition judging forms.
5. Entry of competition judging forms.
6. Calculation of competition scores.

7. Determination of final competition results order.
8. Printing of results.

You will find worksheets that represent the various stages of the competition, score sheets for each competing school, and intermediate and final results. Additional worksheets will be unhidden or generated as you enter more information and progress through entry steps. The visible sheet tabs can be grouped into three categories: 1) input initialization, 2) input judging form information and 3) output results. The initialization tabs will be used to populate the spreadsheet and create individual competition judging form input tabs. A competition judging form tabs will be created for each school you added as a participant in the competition. The short name for the school will be used to name the tab. Each short name must be unique and is auto populated by the spreadsheet. You do not need to enter short names for any schools.

Warning: Many of the sheets within the Scoring Spreadsheet are hidden and later exposed as you enter information. However, there are several sheets that remain hidden and should not be altered in any way.

Warning: Many of the tabs are automatically named by the spreadsheet and that name is referenced elsewhere within the Scoring Spreadsheet. You should never change the name of any tabs in the Scoring Spreadsheet.

Note: The order of the sheet tabs may differ from what is shown in Figure 5. However, the naming and intent remains the same.

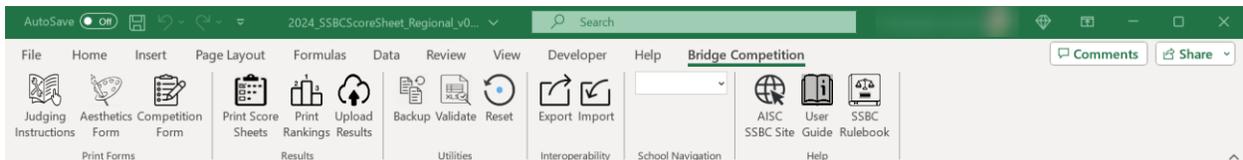


Figure 6: Bridge Competition Ribbon Tab.

Access to global functionality and utilities has been provided in the Excel Ribbon Bar. You will find a tab called “Bridge Competition”. When you select this tab, you will see groups of tools that are specific to the Scoring Spreadsheet (see Figure 6). These groups are “Print Forms”, “Print Results”, “Utilities”, “Interoperability”, “School Navigation” and “Help”. If you hover your mouse pointer over any of the groups of icons, you will see a pop-up appear that provides simple descriptions.

Print Forms: This group contains icons for printing pre-competition forms and instructions.

Print Results: This group contains icons for printing post-competition results.

Utilities: This group contains icons for spreadsheet specific utilities.

Interoperability: This group provides icons for importing and exporting score sheets as XML. Currently, only export is available.

School Navigation: This group provides a picklist that displays the names of the competing schools. It provides easier navigation to locate and view the competition data sheet for a specific school. While the short name for each school is used for naming each competition data worksheet tab, the picklist will show the full name for the competing schools. When you select a name, you will immediately be brought to that school’s competition data sheet tab. This should eliminate the time spent searching for the correct data worksheet tab for larger competitions. Note that the pick list is not populated until you have entered all competing school names on the “Participants” tab and selected “Continue”.

Help: This group provides a link directly to the AISC Student Steel Bridge Competition website where additional helpful information can be found, the current year’s rules book and this user’s guide. Note that these require that you have internet access.

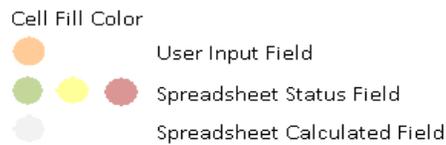
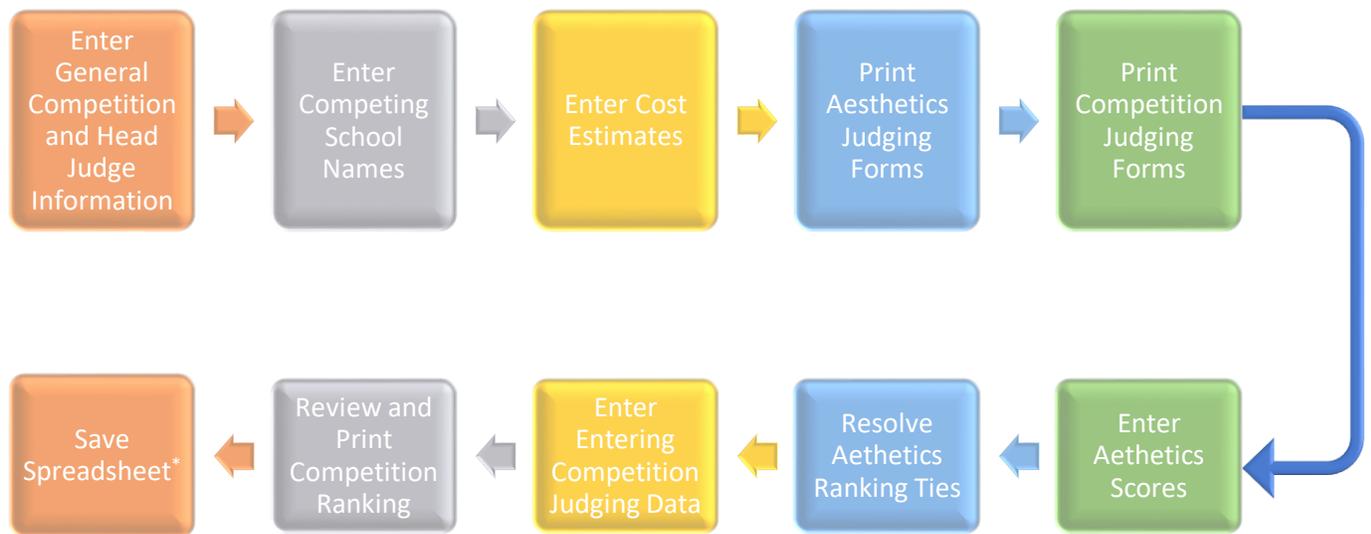


Figure 7: Cell Fill Color Key.

Cells have been filled with different colors to indicate whether they are input fields, calculated values, or status fields. A color key can be found below in Figure 7.

Warning: All sheets within the Scoring Spreadsheet have been protected to prevent inadvertent changes that may break the spreadsheet or cause unexpected results. This means that you will only be able to select and edit cells that are unlocked. While this protection is not password based and any sheet can be manually unprotected, it is inadvisable that you do so.

Use Instructions

The following section outlines the steps to properly operate the Scoring Spreadsheet for a competition. Every competition is composed of two events, the aesthetics judging and competition judging. Before any score can be entered into the Scoring Spreadsheet, the scorekeeper must have a complete list of the names of the schools that will be competing. In general, these steps are shown in Figure 8.

Warning: You should not start populating the Scoring Spreadsheet until you have a complete list of the schools that will be competing.

Entering General Competition and Head Judge Information

The first tab you will be responsible for filling out will be the “Competition Info”. It is here that you will provide basic information about the competition itself, the head judge, and the result of the die roll. Each cell requiring input is highlighted in orange. You will see that a prompt, shown within angle brackets, has been provided in each cell which you will overwrite with actual values. See Figure 9 below.

Picklists for competition name, state name, host school name and die roll results have been provided and you will only be allowed to select or enter specific values. See example shown in Figure 10. The button labeled “Today” will auto populate the “Date” field with today’s date. Alternatively, you can enter this manually using a “mm/dd/yyyy” format.

Once you have finished entering the competition information, you need to provide the name and contact information for the head judge of the competition. The phone number field expects you to enter a 10-digit number consisting of a 3-digit area code and 7-digit phone number. The cell will automatically reformat to the 10-digits to the common (xxx) xxx-xxxx format.

Before timed construction of the first bridge, the head judge will roll a 6-sided die to determine the locations of decking units and where the lateral load will be applied. This value must be recorded in the Scoring Spreadsheet. The corresponding value for “L” will then be displayed in feet and inches. Refer to the Student Steel Bridge Competition Rules for more information.

Before proceeding further, all field must be populated, and you must confirm that you have read the instructions located on the “Readme First” tab. Once you have, select “Yes”, press the “Continue” button to proceed onto the next step of entering the names of the competing school.

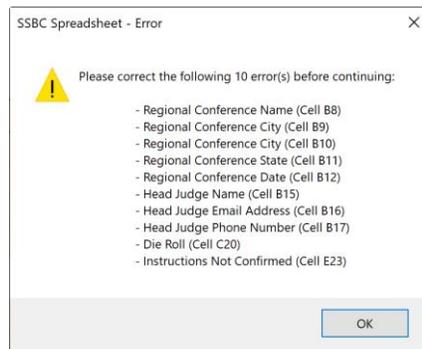


Figure 11: Incomplete Competition Info Error Box.

Note: If you press “Continue” before populating all fields, you will be shown an alert box displaying the information that needs to be corrected before proceeding further (see Figure 11). All errors must be corrected before continuing.

Entering Competing School Names

After populating the information required on the “Competition Info” sheet and pressing the “Continue” button, the “Participants” sheet will be unhidden (see Figure 13). On this sheet you will see a table with 12 columns and 80 rows where each competing school name should be entered. A picklist of competing schools will be displayed when you select the “Full Name” cell. After selecting the school’s name, you should select the appropriate “Guest” status and enter their “Performance Cost Estimate”.

Note: Cells that have a grey fill color should not be edited or modified. These cells will be automatically populate later based on fields elsewhere within the Scoring Spreadsheet. This sheet has been protected to prevent you from selecting and modifying those cells.

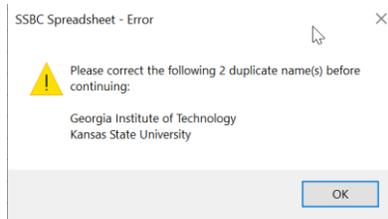


Figure 12: Duplicate Participant Error Dialog.

A sequential row index number is provided in the first column of the table, starting at “1” and ending at “80”. Each row index number should correspond to a unique school name. Figure 13 shows an example of 9 school entries. You should be careful not to enter the same school more than once. If you enter a school name more than once, and error dialog will be displayed when you press the continue button (see Figure 12). You will need to correct any errors before continuing.

Each competing school should be entered one after another starting at the row with “Index 1” and continuing downward until all schools are entered. You should not leave any blank rows or gaps between consecutive school names.

A “Reset” button has been provided which will clear everything in the Scoring Spreadsheet except for the information entered on the “Competition Info” sheet. The reset cannot be undone and should be used with caution. A confirmation dialog will be displayed before this is done.

Warning: The participant’s reset button will clear the entire spreadsheet except for the “Competition Info” sheet. This operation cannot be undone once completed.

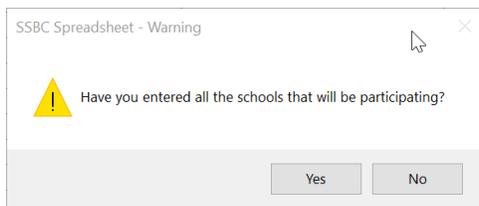


Figure 14: Participants Sheet Continue Warning Dialog.

When you have finished entering all names for the schools that are competing, press the “Continue” button. This will then populate the Scoring Spreadsheet with a sheet for each school. A warning dialog will then be displayed to confirm that you have entered all schools. If you have entered all the correct names, press “Yes”, otherwise “No” (see Figure 14). You will see the Scoring Spreadsheet flicker as sheets are added. A progress message will be displayed in the lower left corner of Excel.

Note: The Scoring Spreadsheet may flicker as it automatically populates itself after confirming that you have entered the named of all the schools that will be participating. This is normal and you should refrain from any extraneous mouse or keyboard clicks until it has completed.

The Scoring Spreadsheet will now be populated with a worksheet for each competing school. The “Short Name” shown in the participants table will be used to name each worksheet (see Figure 15). Navigating between school worksheets can be accomplished by either clicking on the worksheet tab or using the “School Navigation” list available in the “Bridge Competition” ribbon bar. You will notice that contact information shown in the last seven rows of the participants table have been populated with placeholder strings. These are direct references to each school’s data form worksheet where you will enter this information. Reminder, you should not modify any cells that are filled with a grey color.

Notice that the performance costs estimate cells are empty. These values will be populated based upon the die roll entered on the competition sheet and the cost information entered on the “Cost Estimates” sheet. A lookup will be performed that matches the school’s name to the cost estimates table and then the associated die roll. The next section of this manual describes the process of entering cost estimates.

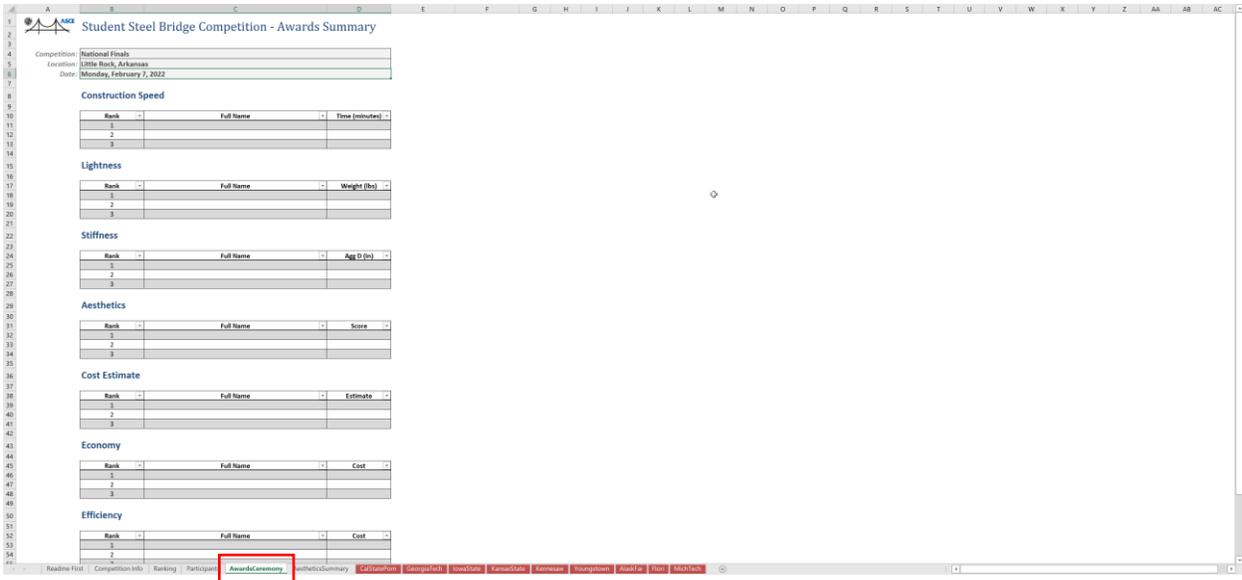


Figure 17: Empty Awards Summary Worksheet.

In addition to a school data form worksheets for each participating school you entered, you will also see tabs for “Ranking” (Figure 16), “AwardsCeremony” (Figure 17) and “AestheticsSummary” (Figure 29). The “Ranking” and “AestheticsSummary” worksheets will be initialized with the names of the competing schools that were entered on the “Participants” worksheet. The “Ranking” and “AwardsCeremony” worksheets will display competition rankings once all judging information has been entered. You will not need to enter or modify the information presented on either worksheet. There is more discussion on each in later sections of this guide.

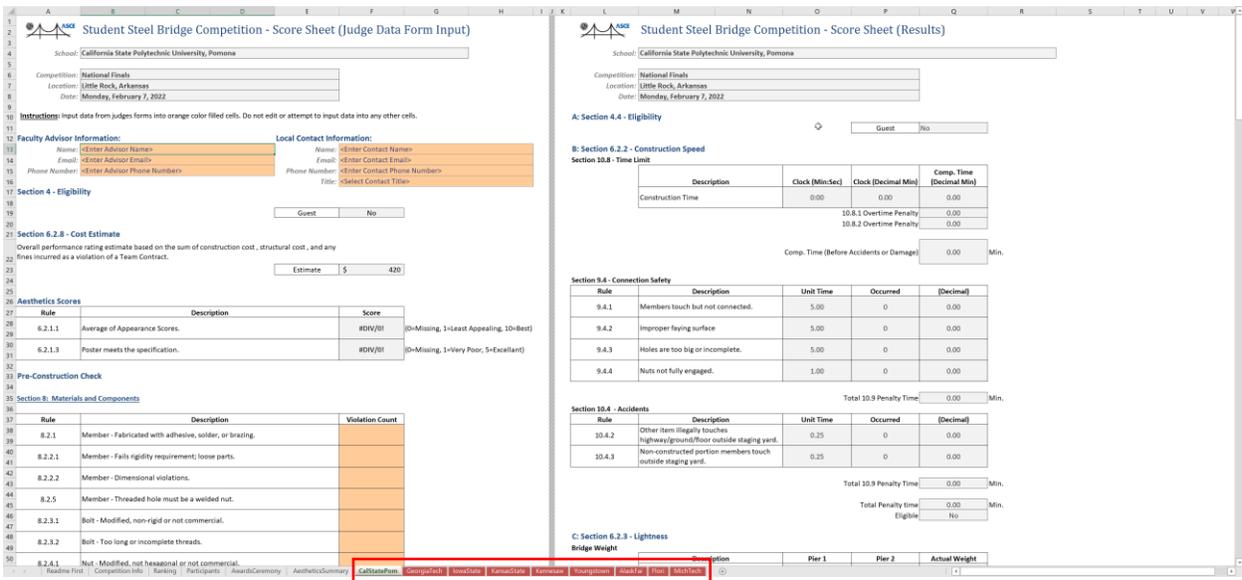


Figure 18: Empty School Judge Data Form Worksheet.

Entering Cost Estimates

An award category based on the estimate of the expected overall performance rating of a team's bridge is submitted to the host school prior to the selection of the controlling load case. The award will be given to the team that best estimates their overall performance rating and completes the competition.

Prior to the selection of the load case as prescribed in Sub-Section 7.1(8). (e.g., at the captain's meeting), all teams will submit their estimated overall performance rating to the host school for all 6 load cases. The host school will input the values for all load cases into the scoring spreadsheet in the table on the "Cost Estimates" sheet. These values will be dynamically updated in the table on the "Participants" sheet based upon the die roll.

The “Cost Estimates” sheet will display once the “Entering Competing School Names” steps have been completed and the “Continue” button pressed. The “Costs Estimates” table will only contain the names of the competing schools entered on the “Participants” table (see Figure 19).

The estimated for overall performance for all 6 load cases, which was submitted to the host school prior to the competition, shall be entered into the “Cost Estimates” table. At a minimum, the values corresponding to the die roll must be entered. However, ideally, all values should be entered for all 6 load cases for each competing school (see Figure 20).

Printing Aesthetics Judging Forms

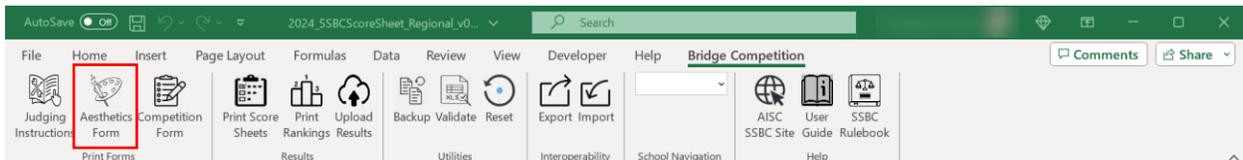


Figure 22: Print Aesthetics Forms Ribbon Bar Icon.

Aesthetics judging forms can be printed from the Scoring Spreadsheet by clicking on the “Aesthetics Form” icon in the “Bridge Competition” ribbon bar (see Figure 22). This should be done after the names of all competing schools have been entered in the participant’s table.

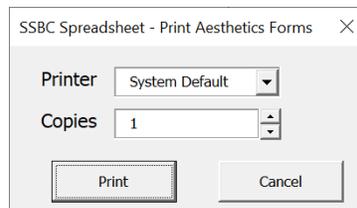


Figure 23: Print Aesthetics Forms Dialog.

After clicking the “Aesthetics Form” icon, a dialog (Figure 23) will be shown that will allow you to select the printer output type; either “System Default” or “Print to PDF”. If you select “System Default”, you will be able to set the number of copies that you want to print. If you use the “Print to PDF”, a PDF will be created in the same folder as the Scoring Spreadsheet. You can then open the PDF in Adobe Acrobat or similar PDF viewer that you can also print from. The “Copies” option will be greyed out by default when you select “Print to PDF”.

An example of the resulting PDF is shown in Figure 24. A judging form should be printed for each judge up to 9. Once aesthetics judging has completed, the scores from each judge should be entered into the Scoring Spreadsheet on the “AestheticsSummary” worksheet.

Note: The aesthetics judging form shown above can be found by un hiding the “AestheticsForm” tab in the Scoring Spreadsheet. However, you should not need to unhide this or any other hidden worksheet.

Printing Competition Judging Forms

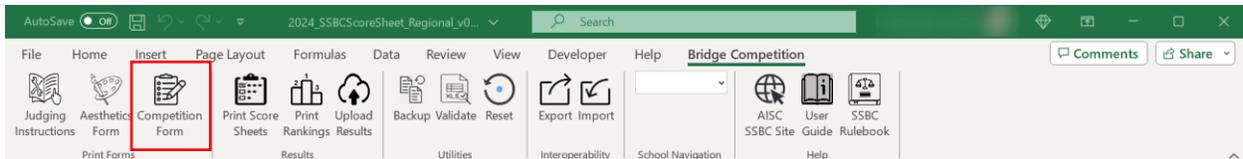


Figure 25: Print School Competition Judging Forms Ribbon Bar Icon.

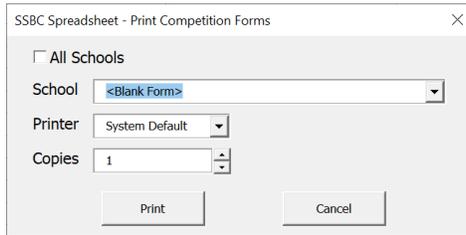


Figure 26: Print Competition Forms Dialog.

Competition judging forms for each school can be printed by clicking on the “Competition Form” icon located on the “Bridge Competition” ribbon bar (see Figure 25). A print competition forms dialog will then be displayed (see Figure 26).

The “Print Competition Forms” dialog will allow you to print in one of three ways. First, you can print a blank competition judging form which has the school’s name left empty. This can be done by selecting “<Blank Form>” from the “School” drop down list. The second option allows you to print individual competition judging forms for any of the participating schools. If you activate the “School” drop down list, you will see the names of each of the schools that were entered in the participants table earlier (see Figure 27). The third option will allow you to print competition judging forms for all schools at once. This

can be done by checking the “All Schools” checkbox. Note that the “School” drop down list will then be greyed out.

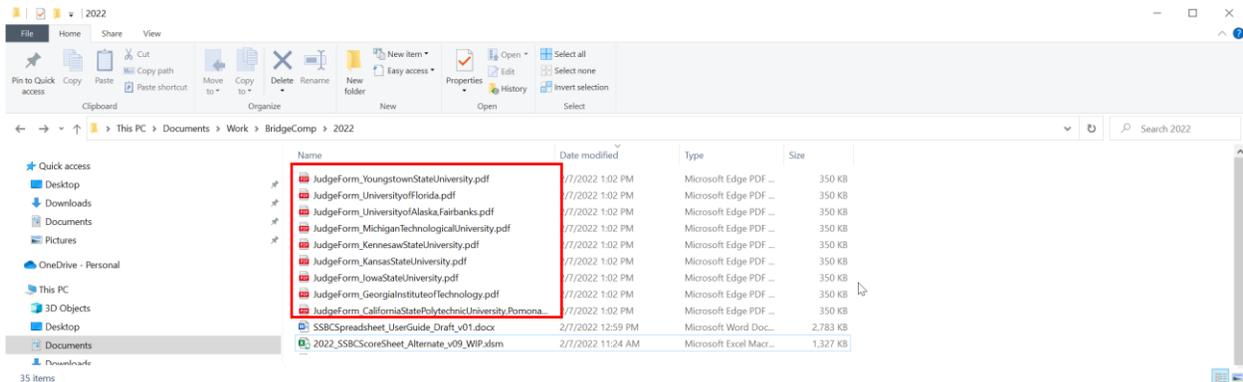


Figure 28: Individual PDF Competition Judging Forms.

Printer output can be either set to “System Default”, which will default the print output to the system printer designated by the operating system, or “Print to PDF” which will create a PDF in the same directory as the Scoring Spreadsheet. Note that if you have “All Schools” checked and select “Print to PDF”, individual PDFs will be created for each participating school. Each file name will have the format “JudgeForm_SchoolName.pdf” (see Figure 28) and have the school’s name pre-populated on each judging sheet.

Entering Aesthetics Scores

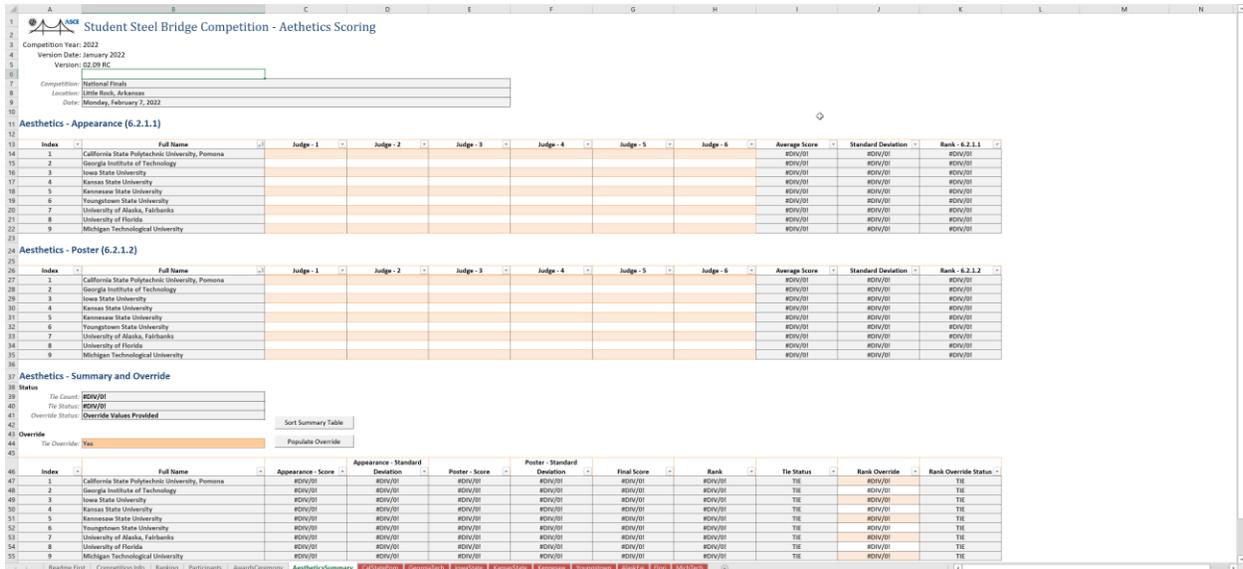


Figure 29: Initialized Empty Aesthetics Scoring Worksheet.

When aesthetics judging has been completed, the scores from each of the aesthetics judges must be entered into the Scoring Spreadsheet on the “AestheticsSummary” worksheet (Figure 29). Space is provided for only a maximum of 9 aesthetics judges. Although there are spaces for 9 aesthetics judges, there may be less at some competitions. If that is the case, you should leave the fields for the other judge’s scores blank.

You will find two tables on the “AestheticsSummary” worksheet: one for “Appearance” scores and another for “Poster” scores. As is the case with all other worksheets, although the worksheet has been protected, you should not modify and cell that has a grey fill color.

Aesthetics scores are primarily used to decide competition results order for the aesthetics awards. However, aesthetics scores are also used to break any ties that may result in the other competition categories. This means that **no ties can exist in the aesthetics competition order** and it is up to the score keeper to resolve them before the end of the competition.

For example, consider results shown in Figure 30 below which shows the “Summary and Override” region of the “AestheticsSummary” tab. Here we have 9 competing schools where a tie exists for 4th place. You can determine this by looking at the “Rank” and “Tie Status” columns. In the “Rank” column you will see that “4” appears twice and “TIE” is displayed in the “Tie Status” column of the same row.

Initially the aesthetics summary table order is arbitrary and will not match the actual aesthetics competition results order. So, a “Sort Summary Table” button has been provided to sort the summary table based on the initial ranking, followed by the appearance standard deviation, poster standard deviation and then alphabetically by school name. Rank and standard deviations are sorted from smallest to largest. So, emphasis is placed on smaller standard deviations for appearance and then poster. In almost all instances, the standard deviations for one or the other will be different enough that you can break ties. However, in the instance below, they are the same. The next section will discuss the methods of breaking ties if they occur.

Resolving Aesthetics Ties

To assist you with identifying ties, status fields are provided under the “Summary and Override” area of the “AestheticsSummary” worksheet (See Figure 31). Here you will find the following fields:

Tie Count: This displays the total number of schools that have ties. For example, if there is a tie between “School A”, “Schools B” and “School C”, the count will be “3”. You must resolve all ties until the “Tie Count” is zero. The cell will also be show with a red fill if there are any ties.

Tie Status: This displays a prompt indicating whether a tie exists or not. The prompt will either be “Ties Found” or “No Ties Found”. Like the “Tie Count” cell, it too will be show with red fill if there are any ties.

Override Status: This displays the current aesthetics competition results order override state and is synchronized with the “Tie Override” option state. It will display “NA” if “Tie Override” is set to “No” and “Override Values Provided” when the “Tie Override” is set to “Yes”.

When a tie exists, there are two ways of resolving them. The first is using the “Populate Override” button and the second is manually. Before using either, you must first set the “Tie Override” option to “Yes”. This will indicate that the competition order will be that shown in the “Rank Override” column. If the override option is “No”, the competition order shown in the “Rank” columns is used.

Populate Override: In cases where there are ties and there are differences in the appearance and/or poster standard deviations for the schools that are tied, the “Populate Override” button can be used. However, first you must set the “Tie Override” to “Yes”. Pressing the override button will inject a formula into the “Rank Override” column that will automatically re-sort and re-rank all schools. This method cannot be used if the scores and standard deviations are the same for the tied schools. In these instances, you will need to use the manual method described below.

Manual: In cases where there are ties and the appearance and/or poster standard deviations are the same, the ranking must be manually overridden. This can be accomplished by first setting the “Tie Override” to “Yes” and then manually typing in the final ranking for all schools in the “Rank Override” column. The score keeper should confer with the head judge and/or aesthetics judges

on how best to assign rankings so that they are done fairly. Again, you cannot have ties in the aesthetics rankings.

Note: If “Tie Override” is set to “Yes” and there are still ties in the “Rank Override” column, the “Tie Count” and “Tie Status” will indicate this, and the word “TIE” will be displayed in the “Rank Override Status” column. Given the importance of resolving ties, this provides an added layer of protection against missing a tie.

Ties are not considered resolved until “Tie Count” is “0” and “Tie Status” is “No Ties Found”. See example shown below in Figure 32.

Entering Competition Judging Data

Individual worksheet will have been automatically created for each school that is participating in the competition. These were created when the participants table was populated and the “Continue” button was pressed. The participants table includes a “Short Name” for each school, and this is used to name that school’s corresponding judging data worksheet. See Figure 33 for example.

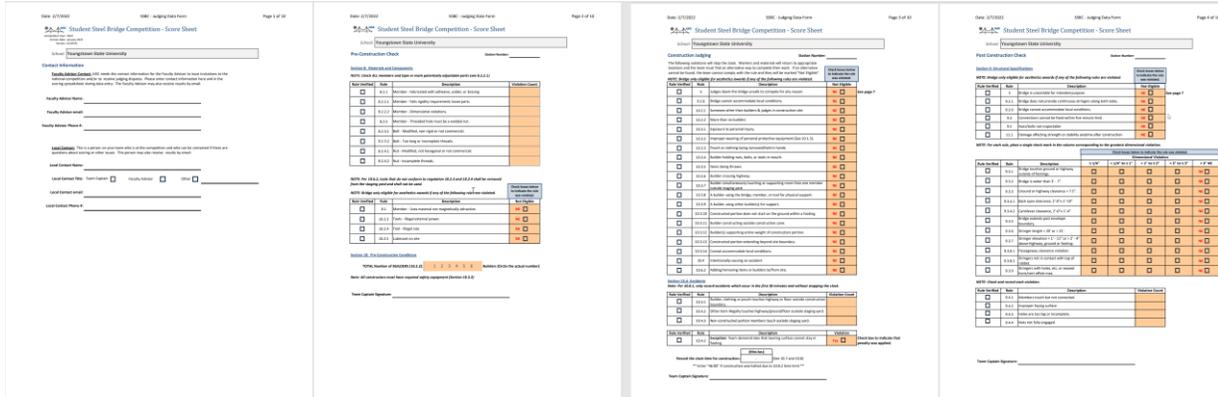


Figure 34: Select Physical Competition Judging Forms.

The judge data input worksheets (Figure 35) are formatted to resemble the physical competition judging forms (Figure 34) used during the competition. This will make transferring the data collected and written on the physical competition judging forms during the competition easier to transcribe. Only cells with an

orange fill color can be modified. These will correspond to the orange fields on the physical competition judging forms.

Note: Verify the school’s name shown on the physical competition judging forms against the school’s name shown on the judge data form input worksheet before entering any values. It is important that that all information be entered accurately.

There are two “sides” to the judge data form input worksheet. The lefthand side is the area where you will transcribe the data collected on the physical competition judging forms. The righthand side are the series of calculations that correspond to the competition rules and are the basis of the final competition results order. You should make no edits or changes to any cell on the righthand side of the worksheet. The worksheet has been protected to prevent inadvertent changes from happening.

Note: You do not have to enter zero in “Violation Count” fields if there were no violations. You can leave these blank.

Some fields contain dropdown lists. For example, if you select a “Not Eligible” cell, you will see a dropdown list appear that has “NE” as an option. If the school has been ruled not eligible for any rule, you will set its value to “NE”. Otherwise, you will leave the cell blank.

When a dimensional violation is documented on the physical competition judging form, you will select “Yes” from the dropdown list for the corresponding dimension range. For example, if a team had a dimensional violation less than or equal to 1/4” for rule 9.3.1, you would select the “≤ 1/4” cell for that rule and set it to “Yes” (see Figure 37).

Note: If there are any dimensional violations, you should only have one “Yes” selected per rule. That means you cannot violate more than one dimension measurement for any one rule.

Note: For each rule, select 'Yes' in the column corresponding to the greatest dimensional violation. Leave blank if there are no violations.

This process will be repeated for each of the schools competing. When you have transcribed all of the information from the physical competition judging form, you are done.

Review and Print Competition Ranking

Once all schools have completed competing and their information has been entered into the spreadsheet, you can view the final ranking for all the categories. You will find a complete list of ranking on the “Ranking” worksheet.

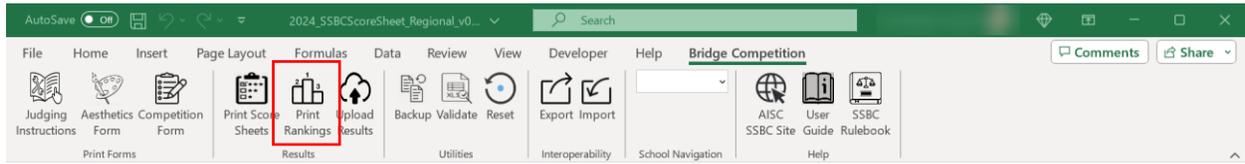


Figure 38: Print Competition Rankings Ribbon Bar Icon.

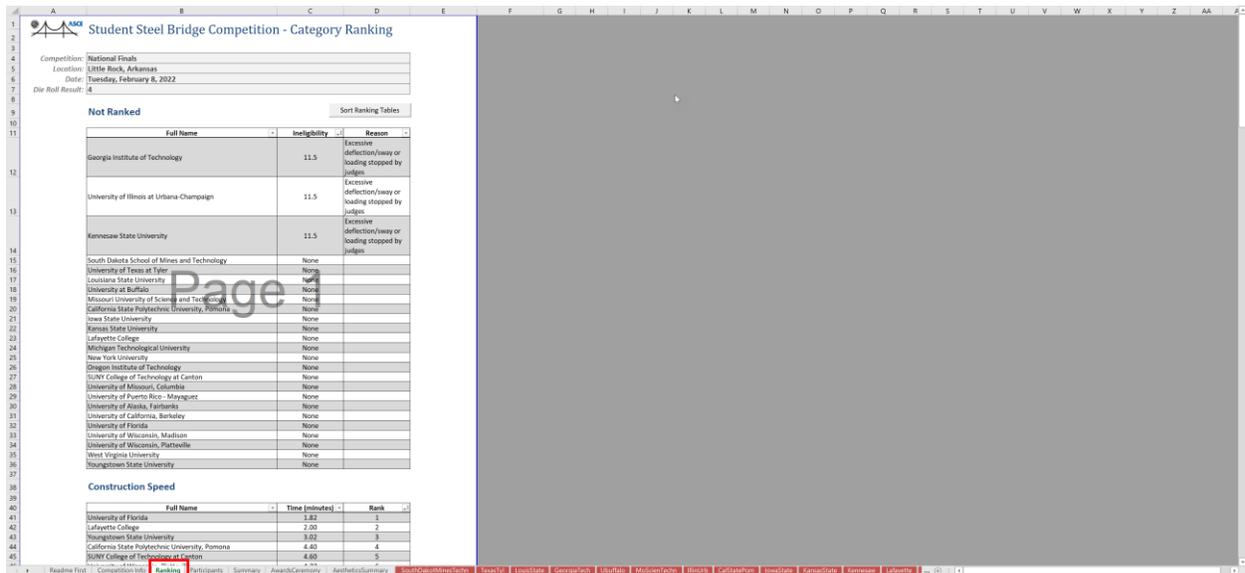


Figure 39: Ranking Worksheet Print Layout.

The “Ranking” worksheet will initial be displayed unordered (see Figure 39). A “Sort Ranking Tables” button has been provided which will automatically sort all the tables by rank from smallest to largest. It is advisable that you sort the tables before printing them. To print the complete competition rankings, press the icon “Rankings” which can be found in the “Bridge Competition” ribbon bar (see Figure 38). You

will have two output options for printing: either to the system default printer or as a PDF. If you choose to print to a PDF, the file will be created in the same folder as the Scoring Spreadsheet.

Note: You may want to adjust the print area before printing the final competition rankings. This can be done by selecting the “Ranking” worksheet and adjusting the page breaks as you would normally do in Excel.

Note: You should sort all results ranking tables before printing. This can be done by pressing the “Sort Ranking Tables” button located towards the top of the worksheet.

Spreadsheet Utilities

The Scoring Spreadsheet include a couple useful utilities which you may want to use. They are described as follows.

Backup: It is good practice to periodically create a backup of your spreadsheet as you enter information. Should there be a problem, you can revert to one of the backups so that you do not have to re-enter information from scratch. When you press the “Backup” icon, a duplicate of the current spreadsheet and its state will be created in the same folder as the spreadsheet that is opened. The backup file name will be the same as the current file with the date and time of creation appended to it. For example, “myfilename_yyyy-mm-dd_hh_mm_ss.xlsx”.

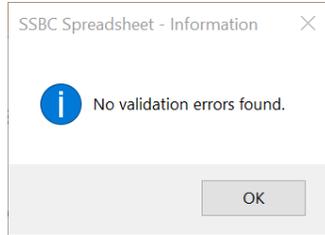


Figure 40: Scoring Spreadsheet Validation Check – No Error.

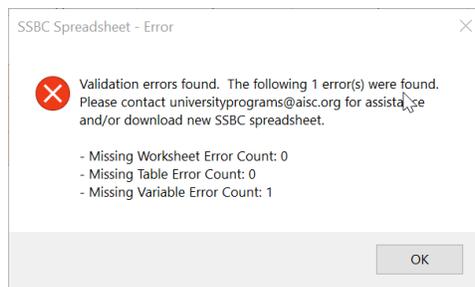


Figure 41: Scoring Spreadsheet Validation Check - Error.

Validate: The validate button is intended to check for errors in with the Scoring Spreadsheet. It will report if there are missing sheet, tables, and variables. This feature can be used to help quickly

debug a spreadsheet that is not behaving as expected. You should obtain a new version of the Scoring Spreadsheet and/or contact AISC for more information if any errors reported. Figure 40 shows the dialog displayed when there are no errors and Figure 41 shows the dialog displayed when there are errors with the Scoring Spreadsheet.

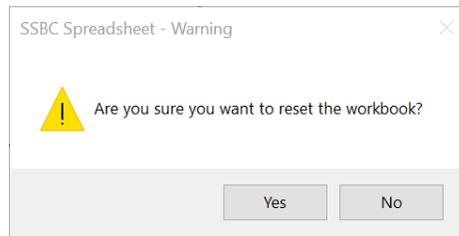


Figure 42: Spreadsheet Reset Warning Dialog.

Reset: This icon will clear the current spreadsheet and set it back to a “clean-state”. A warning message will appear asking if you are sure you want to reset the spreadsheet or not (Figure 42). There is no way to undo a reset and this feature should be used with caution.

Upload Competition Files

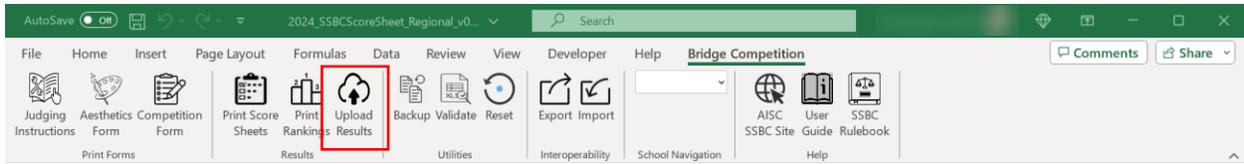
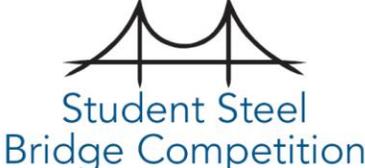


Figure 43: Upload Competition Judging and Results Information Ribbon Bar Icon.

At the conclusion of the competition, you must scan all judging forms, including those used for aesthetics judging. A single PDF with all forms is preferred. These scans must be uploaded along with the final Excel competition scoring spreadsheet. Make sure that you have saved the spreadsheet before uploading it. The spreadsheet will be checked against the scans of the judging forms for correctness. A button has been provided in the ribbon bar which will take you to the online upload form. Note that an internet connection is necessary (Figure 43).

Appendix B – Scoring Spreadsheet School Lookup

The competition name selected on the “Competition Info” tab is used to populate school picklists used on the “Participants” worksheet. A hidden worksheet called “Lookup - School” contains a table listing schools and their assigned ASCE competition region (Figure 45). This table was prepopulated before the Scoring Spreadsheet was posted for download. As is the case with other worksheets, any field that is grey should not be modified.

If a school has been incorrectly assigned to a region, you can manually change the assignment by un hiding the “Lookup - School” worksheet, locating the school’s name and changing the “Region Name” assignment. Once you have done this, you will need to reset the workbook and reenter the competition information before this change to takes place across the Scoring Spreadsheet. You should then notice that the school picklist on the “Participants” worksheet reflects the change and includes any schools you modified.

As is the case with all hidden worksheets, you should not have the need to unhide these manually. However, in this instance, when a school is not being shown on the participants worksheet picklist, un hiding and changing a hidden worksheet might be necessary.

Appendix C – Frequently Asked Questions

How do I enter participant names without first knowing the die roll? The Scoring Spreadsheet verifies that all values on the “Competition Info” sheet have been populated before allowing you to move onto the next step of entering participating school names and then printing pre-populated competition forms. However, in some instances, you may not have performed the die roll yet. If that is the case, you can enter or select an arbitrary value for the die roll as a placeholder until you have performed the actual competition die roll. Once you have, you should go back to the “Competition Info” sheet and enter the actual value. Make sure that you enter the actual competition die roll value before submitting the official competition Scoring Spreadsheet.
