This bulletin describes how AISC Certification site audits are scheduled and includes the 2018 and 2019 Audit Schedules.

An experience, common to all AISC certified companies, is receipt of your annual invoice, which includes your renewal site audit date. This date, set by the QMC auditor, is scheduled to fall within a window of time, called the *audit window*.

What is an Audit Window? - It is the timeframe, set by AISC, during which a company's annual site audit is to occur. The audit window is tied to certificate expiration and begins about 120 days before certificate expiration and concludes about 90 days before certificate expiration.

Conducting the site audit during the audit window allows for:

- **Bundling** of audits
- Sufficient time for the company to resolve any Corrective Action Requests (CARs)
- A rigorous review process, including audit accuracy and compliance
- A review of the previous two years of audit history
- A review of all findings by the AISC Certification Review Group who issues the final determination for certification

What is bundling? - It is the process of combining two or more audits into one audit package allowing one auditor to conduct multiple audits in the same geographical area during the same week. Bundling minimizes travel and other auditing costs and keeps certification fees low.

You may have wondered why AISC charges a fee when a company wants to reschedule an audit. The fee is to recover the additional costs incurred when the audit package is broken to accommodate the re-schedule.

To help you plan for your 2018 and 2019 audits, the Certification Department is publishing the following audit schedules. Though the vast majority of audits will follow this schedule, there will be situations where the audit date will fall outside of the audit window, such as if there is a change in audit scope, a reschedule of the audit date, or a change in auditor's availability.
