Expedited Application Process Optional for either a initial applicant or a certified participant's Scope Change. Includes moving to the top of the list for reviews (eligibility and corrective action request review), the Stage 1 audit, and the site audit will be conducted within 60 days of the Stage 1 completion. The fee is non-refundable.		\$5,000
Certification & Endorsement Scope Change (Optional for participants only) Applicable when a participant requests an additional certification or endorsement. This will include an eligibility review, Stage 1 audit, and a site audit.	Contact AISC	
Pre-Assessment/Gap Analysis (Optional) The pre-assessment is conducted to assist a non-certified company considering certification in determining the implementation status of their quality management system.		\$3,000

Rescheduled Site Audit Applicable if an auditee has an approved request to their annual, renewal audit. Please see Sections 4.3 & 4.4 of the <i>Governing Requirements for Certification Programs</i> .	Contact AISC	
Additional Site Audit Applicable as a follow-up to a renewal, initial, appeal, or complaint audit, and it may be required for the participant or applicant's certification to continue or be granted. Eligibility Review Refund If the review is not successfully completed or the application process ends after it is completed, the applicant's fee will be refunded minus the "review fee" to the right.		\$1,000
Stage 1 Audit Refund If the Stage 1 is not successfully completed or the application process ends after it is completed, the applicant's fee will be refunded minus the "review fee" to the right.		\$2,000
