Includes moving to the top of the list for reviews (eligibility and corrective action request review), the Stage 1 audit, and the site audit will be conducted within 60 days of the Stage 1 completion. The fee is non-refundable.		\$6,500
Certification & Endorsement Scope Change (Optional for participants only) Applicable when a participant requests an additional certification or endorsement. This will include an eligibility review, Stage 1 audit, and a site audit.	Contact AISC
