It's not too early, though, to start thinking about steel conferences in 2001 and 2002—especially if you're interested in submitting a paper.

Deadline for submitting an abstract for the 2002 North American Steel Construction Conference is October 1, 2000. While this may seem like a long lead time, it's necessary to plan the nearly 90 presentations offered annually at the conference. The 2002 Conference is scheduled for April 24-27 in Seattle

Submitted abstracts should be no more than 250 words in length, plus supporting materials such as photos or figures. And suggested topics include:

- Innovations in construction
- Innovative low floor to floor systems
- Fire protection/fire engineering
- Erection engineering techniques
- Innovative structural systems
- Innovative approaches to corrosion protection

- Electronic Data Interchange (EDI)
- Connection design
- Government regulations and how they affect the fabricator/erector
- The design, fabrication and erection of

architecturally exposed structural steel

- Innovative bolting/welding applications
- Creative erection solutions for challenging projects.

While it's too late to submit a paper proposal to the 2001 NASCC, it's not too late for the 2001 World Steel Bridge Symposium, scheduled for Oct. 2-5 in Chicago.

Abstracts of 500 words or less are due by Dec. 1, 2000 and the final papers must be received by May 15, 2001.
